As it is given above:

2. Affidavits produced by Management of the school, and after deeply considering the recommendations of District Education Officer and Director of Education Department (Sn. Sec.) Punjab, Chandigarh; Punjab Government has issued the required No Objection Certificate to the school on the basis of following:

1. In future ,on any Complaint /Inspection and if it comes into the notice that information given by the school is wrong or time to time amended instructions sent by Government are not obeyed or written commitments and deposited Affidavits are followed, in this situation at any time Punjab Government can take back issued No Objection Certificate.
2. Teaching of Punjabi up to 10th class will be compulsory in the school and CBSE, New Delhi make compulsory efforts to take the examination of Punjabi language during Boards exams; if this condition will not be followed No Objection Certificate will be taken back immediately .
3. School will obey all notifications issued under R.T.E Act, 2009 by Education Department of Punjab Government and acts according to rules of R.T.E, Act 2009 made for Punjab State.
4. After Being Affiliated to CBSE, New Delhi ,School's management must release salary plus other allowances to the school Teaching staff and Non Teaching Staff Members similar to the salaries being given to Employees of Government and salaries must be through the Account payee Cheque .In case , this order will not be obeyed then issued No Objection Certificate will be taken back by the Government of Punjab.
5. Principal and management of the School will confirm and certify that they will send /give and help to produce any type of required information by District Education Officer and /or by any Senior Officer of Education Department.
