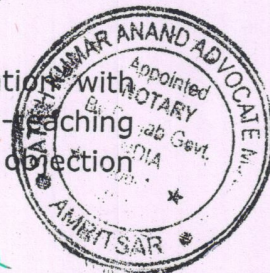

Reference to the aforesaid subject matter:

2. The documents produced by the school management along with affidavit, to District Education Officer (S.S.) and as per the recommendations of Director, Education Department (S.S.), Punjab, Chandigarh, after thoroughly considering the matter the Govt. of Punjab, it is to grant the No Objection Certificate under the terms and conditions mentioned below: -
  1. If in future any complaint or fact being found during the inspection, that you have provided wrong information to the Govt. while obtaining No Objection Certificate and application has been made according to that or you do not comply with instructions issued by the Govt. of Punjab and also do not comply with the written terms mentioned in the affidavit, then in any of that event this No Objection Certificate shall be withdrawn.
  2. The education of Punjabi in your school upto 10<sup>th</sup> standard shall be compulsory and C.B.S.E., New Delhi shall make it compulsory relating to these schools and also it is instructed that if it is not done so, this No Objection Certificate shall be withdrawn immediately.
  3. The school management will follow exactly the rules of R.T.I Act 2009 made for Govt. of Punjab and as per notification issued by Govt. of Punjab, Education Department of R.T.I Act 2009.
  4. That the school management after obtaining the affiliation with C.B.S.E. shall pay the allowances to their teaching and non-teaching staff as per Govt. employees, if it is not done so this no objection certificate shall be withdrawn immediately.

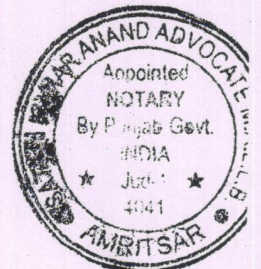
